



# Privacy Notice - Online Store

When you participate in and pay for events at Gorrissen Federspiel in connection with the IBA Conference 2026, we process your personal data. Below you can read how we process your personal data and who you can contact if you have questions regarding our processing.

## **1 Data Controller**

Gorrissen Federspiel is the data controller for the personal data processed about you in connection with registration and payment for events with us:

## **2 Purpose and legal basis for processing**

We process your personal data for the purpose of registering your registration and processing your payment. The legal basis for the processing is the performance of a contract, cf. Article 6(1)(b) of the General Data Protection Regulation (GDPR).

## **3 Categories of personal data**

In connection with your registration and payment for the event in question, we process the following personal data about you:

- First name and last name
- Email address
- Company name
- Order number

## **4 Disclosure of personal data**

We disclose your personal data to our payment provider **Quickpay**, which processes the payment transactions. Since Quickpay is the independent data controller for the processing of your payment data, we refer to Quickpay's privacy notice for further information regarding their processing of your personal data.

## **5 Transfer of personal data to third countries**

Gorrissen Federspiel processes your personal data within the EU/EEA or in countries that have an adequate level of data protection.

## **6 Retention of personal data**

Your personal data is stored only for the period necessary to complete and document the registration and payment for the registered event. The processing of your personal data ceases immediately following the conclusion of the conference, after which your data is deleted, unless specific retention obligations apply.



## 7 Your Rights

Under the GDPR, you have the following rights regarding our processing of your personal data:

- **Right of access** – you have the right to see what personal data we process about you.
- **Right to rectification** – you have the right to have inaccurate personal data corrected.
- **Right to erasure** – in certain cases, you have the right to have your personal data deleted.
- **Right to restriction** – in certain cases, you have the right to have the processing of your personal data restricted.
- **Right to object** – in certain cases, you have the right to object to our processing of your personal data.
